The Pack for small- and medium-sized enterprises presents a significant saving when compared with the cost of contracting all the services separately. In exchange, the contracting company makes a series of commitments:

- 1. To publish in the AECODATA and AECOMEDIA services (including the food information on products if necessary) within no more than three months from the contract date.
- 2. To constantly update the information in both services during the year that the Pack contract is in force.

Companies that fail to comply with the first commitment within the date indicated shall not be eligible to use the SME Pack and shall be required to contract the services separately, assuming the financial losses that this entails.

Those companies contracting the SME Pack that fail to duly update the information during the year of the contract shall not be eligible for this rate in the following year and shall be required to contract the services separately, assuming the financial losses that this entails.
